# Relevant international legislation

1. Council Regulation (EC) No 2201/2003 concerning jurisdiction and recognition and enforcement of judgment in matrimonial matters and in matters of parental responsibility replacing Regulation (EC) No 1347/2000 (Brussels II bis)
2. Council Regulation (EU) No 1259/2010 of 20 December 2010 implementing enhanced cooperation in the area of law applicable to divorce and legal separation (Rome III)

# Hungarian legislation

3. Decree Law No 13 of 1979 on International Civil Law

# Jurisdiction concerning matrimonial matters under Brussels II bis

- chapter II, section 1, article 3
- habitually resident and nationality of spouses are equal principles
- only the nationality of one of the spouses can't determine the jurisdiction of the member state
- it can be that more member states have jurisdiction
- choice of the plaintiff or the parties
- the courts have to examine do they have a jurisdiction or not

(6)- more appropriate to have a single instrument for matters of divorce and parental responsibility

# The meaning of habitual residence of the child

- defined country's territory
- not a simple physical presence but a permanent regular stabile presence
- real center of the child's life
- it can be interrupted

According to the Hungarian Supreme Court

- where the child lives for some length of time (the ordinary residence of the child/recognizable purpose of permanent staying)
- where the child takes part in education
- where the child's extended family other relatives, friends live / where the child can develop these kind of relationships
- where the child's parent works/ earns regular income / has workplace
- where the common residence of the child and his/her parent is situated
- where the child and his/her parent can live together undisturbed

Problem with (6) and Article 12 if the placement is a critical issue between the parties

What is the superior interest of the child?

# The applicable law

The applicable law can be:

1. The law of the member state participating in enhanced cooperation
2. The law of that member state who is not participating in enhanced cooperation
3. The law of that state who is not the member of the EU

# The importance of the time when the parties choose the applicable law

1. When they get married and short time after this event – 2 possibilities
2. During the marriage – 3 possibilities
3. At the end of the marriage – 4 possibilities
